Subject: Summary of Budget Committee actions taken February 24, 2004

On February 24, 2004, the Budget Committee met to discuss actions taken, adjustments, and plans for the following federal program funds:

- Anti-Drug Abuse Act (ADAA)/Byrne Formula Grant federal fiscal years 1997 through 2001.
- Juvenile Accountability Incentive Block Grants (JAIBG) program federal fiscal years 2001 through 2003.
- Violence Against Women Act (VAWA) federal fiscal years 1999 through 2002.
- Victims of Crime Act (VOCA) federal fiscal years 2000 through 2003.

A workshop session was also conducted to address issues relating to undesignated ADAA federal fiscal year 2004 funds and to the adoption of 2004 Byrne Strategy recommendations.

Authority members and designees present were Authority Chair Sheldon Sorosky, Budget Committee Chair Eugene Murphy, Chief David P. Bradford, John Morales for Clerk Brown, Sheriff Timothy Bukowski, Bridget Healy Ryan for State's Attorney Devine, Barbara Engel, Director Norbert Goetten, Clerk Maureen Josh, Ellen Mandeltort for Attorney General Madigan, State's Attorney William A. Mudge, John Toscas, and Deputy Director Ken Bouche for Director Trent.

All of the Budget Committee actions contained in this memo were approved unanimously, including the adoption of the minutes of the November 12, 2003 Budget Committee meeting.

BYRNE (ADAA) FUND STRATEGY WORKSHOP

A workshop focusing on the Authority's Byrne (ADAA) Program strategy was held at the beginning of the meeting. The workshop included a PowerPoint presentation by The Authority's Research and Analysis unit entitled, "Crime and Criminal Justice in Illinois: What Does the Data Tell Us?"

Authority staff made the following federal fiscal year 2004 Byrne (ADAA) strategy priority recommendations. The Budget Committee **approved** each recommendation:

- □ Support prevention programs that help youth recognize risks associated with violent crime and drug use and target youth to reduce their use of violence, illicit drugs, alcohol, and tobacco products; and
- Support programs statewide that target prevention and early intervention for juveniles, with particular emphasis on the principals of balanced and restorative justice.
- □ Support programs that enhance treatment effectiveness, quality, and services so that those who need treatment can receive it.

- □ Support research that identifies what works in drug treatment and the prevention of drug use, violent crime, and their consequences.
- □ Support programs that promote the efficiency and effectiveness of the criminal justice system.
- □ Support efforts to implement an integrated justice system in Illinois that includes all components of the criminal justice system and includes every jurisdiction within the state.

Authority staff made the following general recommendations for use of federal fiscal year 2004 funds. The Budget Committee **approved** each recommendation:

- ☐ Treatment for sex offender parolees from the Illinois Department of Corrections;
- ☐ A special DNA prosecution unit at the Cook County State's Attorney's Office;
- □ Balanced and Restorative Justice (BARJ) projects; and
- □ Other public policy initiatives from the Governor, Authority members, and staff.

VOCA

The Budget Committee reviewed and approved the final designation adjustments for federal fiscal year 2000. The materials presented at the meeting indicated that the Authority would lapse \$45,811 in federal fiscal year 2000 funds back to the Office for Victims of Crime. Subsequent adjustments to the federal fiscal year 2000 Attachment A indicate that the Authority will lapse \$59,820. That is under .04 percent of the total award.

Committee Oversight

Since this memorandum is the official notification of Budget Committee action taken on February 24, 2004, the following is a reminder to the members of the Authority's organizational rules regarding committee oversight. Section 1750.340(I) of the Authority's Organizational Rules states:

i) Oversight of Committees—In order to provide for oversight by the Authority of actions taken by any committee, whether ad hoc or standing, Authority members shall be notified—by phone, mail or equivalent—of all motions passed by a particular committee, within five (5) business days of any committee meeting, or prior to the next meeting of that committee, or before the next meeting of the Authority, whichever is sooner. Within ten (10) business days of receipt of such information, a special meeting of the Authority may be convened upon the request of five (5) Authority members, for the purpose of fully discussing any action taken by a committee and to supersede the authorization granted to the committee to act on the Authority's behalf in any particular matter.

Subject to the oversight process described above, the Budget Committee action becomes the action of the Authority.
